## FLUORESCENT LAMP RECYCLE KIT

### FOR SAFE, COMPLIANT DISPOSAL OF SPENT FLUORESCENT LAMPS AND TUBES

All fluorescent lamps and tubes should be recycled, or taken to a hazardous waste site because they contain mercury. After Feb. 8, 2006, all fluorescent lamps and tubes in California (Title 22, division 4.5, chapter 23, section 66273-8), and 8 other states (New York, Connecticut, Maine, New Hampshire, Massachusetts, Vermont, Wisconsin and Minnesota) must be recycled, or taken to a household hazardous waste disposal facility, a universal waste handler (e.g., storage facility or broker), or an authorized recycling facility. The **FLUORESCENT LAMP RECYCLE KIT** makes it easy because it is a complete recycling solution. Superco's **FLUORESCENT LAMP RECYCLE KIT** provides the Business Community with a Safe, Economical, Compliant Program for recycling Mercury-Containing Fluorescent lamps.

#### INSTRUCTIONS: Four Easy Steps

1. Place spent bulbs in orange MDS bags, fold top of bag 2 times and seal end of bag with self sealing tape.
2. The **FLUORESCENT LAMP RECYCLE KIT** contains a **RED** prepaid shipping label. Do not misplace this label as FEDEX will not pick up box if it is missing.
3. Once the container is full, tape the box closed, complete senders portion of shipping label and attach to end of box.
4. Call FEDEX at 1(800) GO FEDEX and they will pick up the box and deliver it to the recycle center.

**Please note:**

**DO NOT PLACE MORE THAN 30 BULBS IN BOX REGARD-  
LESS OF SIZE. This box is designed to hold 30 lamps.**

**CAUTION:**

- If lamp breakage should occur, place broken glass and bulb constituents in MDS pouch provided and discard as hazardous waste.
- Do not store box outdoors where it can be exposed to weather.
- Do not store spent bulbs for more than 1 year.

Here are a few facts from the EPA: • **Fluorescent bulbs contain small quantities of Mercury** • **25 4ft. fluorescent bulbs contain 1 gram of Mercury.** • **It only takes 1 gram of Mercury to contaminate a 20 acre lake.** • **Over 17 million bulbs are discarded EACH DAY, of which only 3 million are recycled. The balance of 14 million end up in landfills.** • **Enough bulbs are thrown away each month, that if placed end to end, would circle the EARTH THREE TIMES!** Typically, in the past, people would dispose of fluorescent bulbs by simply "throwing them in the garbage". This once acceptable practice is no longer acceptable for businesses under most local, county, and state regulations.
